President Frank Kuntz called the meeting to order at 12:00 pm.

#### **Action and Other Items:**

Mark welcomed new PFD Board Member, City of Cashmere Mayor James Fletcher. Staff was introduced and a brief overview of the facility was given. A facility tour for Mayor Fletcher will be arranged later.

#### **Agenda Items:**

1. Manager's Report

- a. Sales & Marketing Report Lindsay Rey provided an update on sales and marketing activities over the past month. She has only two loge seats available but does have contract/proposal out for them and is just awaiting final approval and signatures. All available suite nightly rentals for all remaining Wild games are sold out. Additional sales of \$4,500 plus a \$7,500 backlit sign are finalized. Jack Daniels has renewed their sponsorship of the upper concourse lounge. All suites are being reviewed for August renewals.
- b. Skyhawks Team Update The team plans to play. We are working on final settlements of last season.

#### c. Shows/Events

- i. Youth Tournaments -3 We have now actually held 5 youth hockey tournaments. Those are doing very well and bring in ice rental revenue.
- ii. Wenatchee Wild The Wenatchee Wild team is scheduled to play 4 games in the month of January.
- iii.Bighorns League The Bighorns first home games is scheduled for March 2. The team has put out a very aggressive marketing schedule. Their prepaid rent has been processed according to the agreement. Ticket sales for first game are just over 900 at present.
- iv.Brett Young Country/Western performance May 12. Ticket sales are at 1,800 and we need between 2,100-2,200 to break even.
- v.Paw Patrol Event is for two performances on March 20 & 21.
- vi.Special Olympics Opening Ceremonies are Friday evening, March 3 with various on-ice competitions on the community rink ice most of the day Saturday, March 4.
- vii.KPQ Home Expo This trade show will be held March 10-12.
- viii.Jordan Circus The circus is scheduled for March 30 & 31. This is a heavily attended event for families with children.
- ix.Hell on Hooves This rough stock rodeo has moved back up to the second Apple Blossom weekend now that the Apple Blossom Carnival has relocated. It's a two-day event on May 5 & 6.
- x.Click-it RV Show Click-it RV will be returning for a two-week RV show in the parking lot.
- xi.Together! For Youth Christian Concert This organization will be hosting Christian music performer Colton Dixon on July 14.
- d. Financial Statements Dave Mann presented the financial activity for the prior month. The sales tax remittances were reviewed. Board member Randy Agnew noted that he would like to request \$15,000 for a firework and Fourth of July community event in Rock Island. Board President requested this be on the agenda for the March PFD meeting. Dave reported the "sweep" account has been set up at Banner Bank and is active. Interest rate is at 3.87%.
- 2. Motion to Authorize the Board Chair to negotiate and sign a revised franchise agreement with Shoot the Puck dba Wenatchee Wild Negotiations are still ongoing regarding the renewal of the Wenatchee Wild contract. Length of term (2 years vs 10 years), costs/expenses (labor, suite tickets costs, ice time rent, comp tickets, CPI built in), etc. are all being discussed. There were some discussions with David White at the hockey game last week and we anticipate an agreement proposal or response from him in the next couple weeks.

Motion was made by Marc Straub to authorize the PFD Board Chairman to negotiate and sign an agreement with Shoot the Puck for a renewal agreement. JC Baldwin seconded the motion.

#### Motion Passed 7-0.

- **3. PFD Board Members Term/Expiration** Update Chelan County has elected to have City of Cashmere Mayor James Fletcher as their representative.
- 4. Sales Tax Report Submitted by Cordell, Neher & Co., PLLC Sales tax report from Cordell, Neher was included in members information packets. Board members did not have any questions.
