#### **Action and Other Items:**

### 1. Manager's Report

- a. Shows/Events
  - i.Wenatchee Wild the team is switching leagues from the BCHL to the WHL effective the 2023-2024 Season. The Board has been asked to support this move.

Motion was made by JC Baldwin and seconded by Jim Fletcher to notify David White, owner of the Shoot the Puck Foundation that the approve and support the move to the WHL. Motion passed 5-0.

The team will keep the name Wenatchee Wild. BCHL players will be relocated to other BCHL teams. The current Winnipeg Ice team will relocate to Wenatchee. The WHL is in the process of adjusting the season game schedule. The arena will go from 26 home games in the BCHL to 34 home games in the WHL. We have had discussion with suite owners regarding the coming price increases due to the increase in games. As an example, a \$17K suites will increase to \$22K per year. All loge seats will increase from \$1,500 WHL does have \$1,800 per year. The some stipulations/requirements. One is all glass must have rounded edges. This will cost approximately \$10K. The glass has been ordered but is currently on backorder. They require an isolated replay booth. The team has ordered the equipment. The requirements for locker rooms will need to be addressed later as they may require construction that will need some engineering, permitting. The WHL is aware that this will not happen prior to the 2023-2024 Season. The lighting in the main arena will need to be addressed. We are in the process of replacing the original LED lights under warranty. However, the companies we are working with have not determined if the 150ft candle requirement can be met with the existing light fixtures. They have asked for a workout/weightlift room which will do not have and will not be able to provide prior to their first season.

- ii.Bighorns The Bighorns had prepaid for some facility rent according to their agreement. They have been sent notices of default.
- iii.Skyhawks The Skyhawks has paid their balance due but will have their final game balance due soon.
- iv.Eastmont High School Graduation The high School had around 450 graduates and the attendance was approximately 5K.
- v.Moline Healthcare Event Will be held in the parking lot.
- vi.Click-It RV Show An RV was stolen over the weekend but it has been located and returned to Click-it. A few safety issues and incidents have occurred recently at other venues including the shooting at the Gorge. We had an altercation between and event person and one of our employees. The police department was on site quickly and resolved the matter.

- b. Sales & Marketing Report Lindsay reported that there has been a very good response from suite and loge seat owners regarding the Wenatchee Wild switch from BCHL to WHL. She has not received any pushback on the price increases. There has been new and renewed interest in ownership of suites and loge seats. Jerrilea Crawford took a moment to recognize Lindsay as one of the newest graduates of the Wenatchee Valley Chamber of Commerce Leadership Class. Lindsay is the fourth Town Toyota Center graduate. Congratulations to Lindsay.
- c. Financial Statements Financial statements for the month of April were presented. The month included three Wild playoff games, three Bighorns games, 3 Skyhawks games. The month of May was also presented. May included the Hell on Hooves Rodeo, Brett Young and three Skyhawks games. One Bighorns game was cancelled. The final settlement for the Hell on Hooves Rodeo will follow in June.
