

The preliminary 2019 budget was presented. A review of some line items included the effects of minimum wage increase, the portion of the budget that covers Wild activity based on the renewed agreement, 12% increase in liability insurance rate, the Chelan County Fire Assessment, Utilities and the renewals of benefit programs. The documents will be updated and emailed out to board members tomorrow.

4. Pending Fulbright Injury Claim

This claim is currently being managed by Enduris, our insurance agency, and legal representatives assigned by them.

5. Capital Projects

- a. Carpet/Flooring, we have received three local quotes that are being reviewed. We are fine tuning the details of the overall project.
- b. Chelan County PUD Projects, Chelan County PUD continues to work with us on energy savings projects both large and small. We are currently looking at energy drapes, additional lighting projects and improvements to some mechanical/equipment areas.
- 6. Wenatchee Wild 2018-2019 Season Home Game Opener. The season's opening game was Friday.

7. Sales and Marketing Report

Jennifer reported activity that has taken place since last month and reviewed the 10 Year Anniversary events. The 10 Year events raised \$18,300 in sponsorships. And the Wenatchee Valley Chamber of Commerce video that the Board had previously agreed to sponsor was premiered at the banquet. The center is no

longer selling Club Seats but we are selling parking passes and they have been well received by our guests.

8. Financial Reports

Shannon review the monthly financial statements and activities with the board members. The sales tax revenues are up approximately 10%. She noted we are currently working on year end projections. Frank inquired about the transfer to the reserve account and Mark requested we make that final decision at the December PFD Board Meeting.
